SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

Summarize rationale supporting determination: **The St. Louis District has determined that the Missouri River is a navigable waterbody subject to Section 10 of the Clean Water Act, from Mile 0 to Mile 50; effective October 1, 1994.**

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: **Wetland 2 is a scrub-shrub wetland located approximately one half-mile from the Missouri River. The distance of adjacency is significant, but is also commensurate with the size of the lower Missouri River. The wetland is located well within the floodplain of the Missouri River. At this location, the floodplain is broad and relatively flat, and extends over one mile from the right-descending bank. In present times, the floodplain has been disconnected from the river by the construction of the Consolidated North County Levee. However, per the May 30, 2007 U.S. Army corps of Engineers Jurisdictional Determination Form Guidebook, wetlands separated from a waterbody by a man-made berm or dike are nonetheless considered adjacent. The project site consists of a former trailer park that was destroyed during the 1993 flood, and subsequently abandoned. Following the removal of the trailers, the site has been primarily unmaintained. Since its abandonment, the site has reverted to conditions similar to early-successional riverfront forest, a habitat type typically associated with adjacent wetland settings. The project site is generally uniform in elevation, with poor internal or external drainage. Wetland 2 exists as a swale-like, linear wetland that may have resulted from the construction of the trailer park. Wetland 2 does not drain off-site, and appears to hold water within the Missouri River floodplain, seasonally and following precipitation.**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
