Interested parties are hereby notified that a request has been received to reauthorize a previously approved project to install rip rap in the Mississippi River along portions of the existing Cape Girardeau Floodwall, as described below and shown on the attached figures.

<u>APPLICANT:</u> U.S. Army Corps of Engineers, Project Management Branch (USACE), 1222 Spruce Street, St. Louis, Missouri 63103-2833.

LOCATION: The project area is located along the right descending bank of the Mississippi River, between approximate river miles 51.6 to 52.8, in Cape Girardeau, Cape Girardeau County, Missouri. (See Attached Map).

PROJECT DESCRIPTION: The project proposal is to reauthorize previously approved Department of the Army permit P-2482, which on September 10, 2005, granted authority to complete repairs to the existing Cape Girardeau Flood Protection system. Funding to complete the previously authorized project has not been available, but is now anticipated sometime within the next three years. The primary repair activity involves stabilization of the existing concrete retaining wall. Additional riprap would be placed in the Mississippi River to form a strengthening rock berm parallel to the existing flood protection structure. The rock berm of A-stone grade rock will be placed riverside of the retaining wall for a distance of approximately 1,607 feet. From elevation 336 NGVD, the rock berm will extend horizontally 20 feet toward the river and then angle down to the river bottom at a 2:1 slope. Approximately 160,700 square feet of river bank will be covered by additional riprap. The

proposed rock berm would extend approximately 100 feet out from the retaining wall and terminate in the river at an approximate elevation of 292 NGVD. The shoreline along the floodwall, where the rock berm will be placed, is rip rapped to 60 feet from the retaining wall.

The previously approved rock berm is still proposed to extend from the river's shoreline approximately 10 to 35 feet into the river. No changes to river hydraulics are anticipated with this berm. The rock berm will stabilize the retaining wall, which will in turn stabilize the foundation of the floodwall, preventing a future failure related to the retaining wall. The main channel will not be impacted by the rock berm and the rock berm may provide some additional shoreline structure in the area. In addition, the placement of the riprap may help reduce costs and the environmental effects of channel maintenance, restore or maintain the natural river processes, and restore and enhance habitat quality.

The rock berm is designed to avoid significant impacts on the operation and maintenance of the existing Mississippi River stream gage station located within the proposed rock berm area. This stream gage is very important to the Corps of Engineers, Cape Girardeau and the Mississippi River industry. A box culvert is still proposed around the existing pump station outlet to extend the outlet and allow placement of the rock berm. The Cape Girardeau Flood Protection Project was authorized by the Flood Control Act of 17 May 1950. Construction was begun in February 1956 and completed in June 1964. The project was formally transferred to the local interests in October 1964.

<u>AUTHORITY:</u> This reauthorization request will be processed under the provisions of Section 10 of the Rivers and Harbor Act and Section 404 of the Clean Water Act.

<u>WATER QUALITY CERTIFICATION:</u> By issuance of this public notice, the project plans are considered submitted to the Missouri Department of Natural Resources, Water Pollution Control Program for state certification of the proposed work in accordance with Section 401 of the Clean Water Act. The certification, if issued, will express the Agency's opinion that the proposed activities will not violate applicable water quality standards. Written comments concerning possible impacts to waters of Missouri should be addressed to: Water Pollution Control Program, P.O. Box 176, Jefferson City, Missouri 65102-0176, with copy provided to the Corps of Engineers.

<u>SECTION 404 (b)(1) EVALUATION:</u> The impact of the activity on the public interest will be evaluated in accordance with the Environmental Protection Agency guidelines pursuant to Section 404 (b)(1) of the Clean Water Act.

<u>PUBLIC HEARING:</u> Any person may request, in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Request for public hearings shall state, with particularity, the reasons for holding the public hearing.

ENDANGERED SPECIES: The proposed project is within range of the endangered Indiana bat (**Myotis sodalis**), Pallid sturgeon (**Scaphirhynchus albus**), the Least Tern (**Sterna antillarum**) and the threatened decurrent false aster (**Boltonia decurrens**). A preliminary determination, in compliance with the Endangered Species Act as amended, has been made that this proposed activity is not likely to affect species designated as threatened or endangered, or adversely affect critical habitat. In order to complete our evaluation, comments are solicited by this public notice from the U.S. Fish and Wildlife Service and other interested agencies and individuals.

<u>CULTURAL RESOURCES:</u> The St. Louis District will evaluate information provided by the State Historic Preservation Officer and the public in response to this public notice and we may conduct, or require a reconnaissance survey of the project area.

EVALUATION: The decision whether to issue a permit will be based on an evaluation of the probable impact including cumulative impacts of the described activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefit that may reasonably be expected to accrue from the described activity must be balanced against its reasonably foreseeable detriments. All factors, which may be relevant to the described activity will be considered including the cumulative effects thereof; among those are conservation, economics, aesthetics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, flood plain values, land use, navigation, shoreline erosion, and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, consideration of property ownership and, in general, the needs and welfare of the people.

The U.S. Army Corps of Engineers is soliciting comments from the public; Federal, state, and local agencies and officials; Indian Tribes; and other interested parties in order to consider and evaluate the impacts of these proposed activities. Any comments received will be considered by the U.S. Army Corps of Engineers to determine whether to issue, modify, condition or deny a permit for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and other public interest factors listed above. Comments are used in the preparation of an Environmental Assessment and/or an Environmental Impact Statement pursuant to the National Environmental Policy Act. Comments are also used to determine the need for a public hearing and to determine the overall public interest of the proposed activity.

In accordance with 33 CFR 325.3, it is presumed that all interested parties and agencies will wish to respond to public notices; therefore, a lack of response will be interpreted as meaning that there is no objection to the proposed project.
